**RESOLUTION TO ADOPT THE HUDSON COUNTY
VISION ZERO SAFETY ACTION PLAN AND THE
TARGET YEAR FOR ZERO DEATHS ON COUNTY ROADS AS 2034**

WHEREAS, the United States Department of Transportation (USDOT) Safe Streets and Roads for All (SS4A) discretionary grant program funds regional, local and Tribal initiatives to prevent roadway deaths and serious injuries; and

WHEREAS, the County was previously awarded a SS4A Planning Grant through the USDOT to develop the Hudson County Vision Zero Safety Action Plan (the "Plan"); and

WHEREAS, in August 2023, the County established the Vision Zero Task Force by Executive Order to ensure intercounty collaboration on the Plan; and

WHEREAS, the Vision Zero Task Force has met routinely since November 2023 to inform creation of the Plan; and

WHEREAS, the Vision Zero Task Force developed the Plan, which was opened to public comment on February 14, 2025, was posted on the County's Vision Zero website and was the subject of a public hearing held on March 6, 2025; and

WHEREAS, public comments that were received will be addressed in the Task Force's 2025 Annual Process Report; and

WHEREAS, adoption of the Plan and target year satisfies the requirements of the SS4A Planning Grant awarded to the County to support the creation of the Plan and will allow the County to become eligible to apply to implementation funding for street design improvements; and

WHEREAS, it is in the best interests of Hudson County to approve the Hudson County Vision Zero Action Plan and Target Year for zero deaths on County Roads as 2034.

NOW, THEREFORE, BE IT RESOLVED, by the Board of Commissioners of the County of Hudson, that:

1. The aforesaid recitals are incorporated herein as though fully set forth at length.
2. The Board hereby authorizes the County Executive, Craig Guy, or County Administrator, Abraham Antun, or Deputy County Administrator, David B. Drumeler, or their lawfully appointed designee, to execute any and all documents and take any and all actions necessary to complete and realize the intent and purpose of this Resolution.
3. The Hudson County Vision Zero Action Plan and Target Year for zero deaths on County Roads as 2034, is hereby adopted as an official plan of the County of Hudson; minor revisions recommended by the USDOT may be incorporated without further action.
4. Any action proposed by the Plan shall be subject to and contingent upon budget approval, if required, which shall be at the discretion of the County of Hudson, and this resolution shall not be interpreted so as to mandate any such appropriations.
