AUTHORIZING AN APPLICATION AND ACCEPTANCE OF FUNDS, IF AWARDED,
 FROM THE NEW JERSEY TRANSIT CORPORATION
 FOR THE SENIOR CITIZENS AND DISABLED RESIDENTS'
 TRANSPORTATION ASSISTANCE PROGRAM (SCDRTAP)
 JANUARY 1, 2024 TO DECEMBER 31, 2024
 (\$1,880,842.00)

WHEREAS, The New Jersey Transit Corporation has notified the County of Hudson, through the Department of Health and Human Services, that the County of Hudson is eligible to receive funding for calendar year 2024 under the "Senior Citizen and Disabled Resident Assistance Act" in the amount of ONE MILLION EIGHT HUNDRED EIGHTY THOUSAND EIGHT HUNDRED FORTY TWO DOLLARS AND 00/100 (\$1,880,842.00); and

WHEREAS, it is necessary to submit a formal application to the New Jersey Transit Corporation in order to obtain the grant funds; and

WHEREAS, the funding will provide vital transportation services to eligible residents of Hudson County for travel to medical appointments, nutritional centers, shopping locations, recreational areas, educational centers and certain employment and transportation hubs.

WHEREAS, it is advantageous to the County to apply for and accept any grant funds awarded.


NOW, THEREFORE, BE IT RESOLVED, by the Board of Commissioners of the County of Hudson, that:


1. The aforesaid recitals are incorporated herein as though fully set forth at length.
