**AUTHORIZING AN APPLICATION AND ACCEPTANCE OF FUNDS, IF AWARDED,
FROM THE NEW JERSEY TRANSIT CORPORATION FOR THE SENIOR CITIZENS
AND DISABLED RESIDENTS TRANSPORTATION ASSISTANCE PROGRAM
(SCDRTAP) FOR CY 2025**

JANUARY 1, 2025 THROUGH DECEMBER 31, 2025

WHEREAS, The New Jersey Transit Corporation has notified the County of Hudson, through the Department of Aging and Veterans Affairs, that the County of Hudson is eligible to receive funding for calendar year 2025 under the "Senior Citizen and Disabled Resident Assistance Act" in the amount of **TWO MILLION FIFTY FOUR THOUSAND THREE HUNDRED EIGHTY EIGHT DOLLARS AND 00/100 (\$2,054,388.00)**; and

WHEREAS, it is necessary to submit a formal application to the New Jersey Transit Corporation in order to obtain the grant funds; and

WHEREAS, the funding will provide vital transportation services to eligible residents of Hudson County for travel to medical appointments, nutritional center, shopping locations, recreational areas, educational center and certain employment and transportation hubs; and

WHEREAS, it is advantageous to the County to apply for and accept any grant funds awarded.

NOW, THEREFORE, BE IT RESOLVED, by the Board of Commissioners of the County of Hudson, that:

1. The aforesaid recitals are incorporated herein as though fully set forth at length.
2. The Board hereby authorizes the County Executive, Craig Guy, or County Administrator, Abraham Antun, or Deputy County Administrator, David B. Drumeler, or their lawfully appointed designee to execute any and all documents and take any and all actions necessary to complete and realize the intent and purpose of this resolution.
3. An application for grant funds and acceptance of same is hereby authorized for the above referenced program.
