WHEREAS, by way of Resolution No. 349-6-2018, this Board accepted funds from the New Jersey State Department of Labor and Workforce Development for the Workfirst New Jersey Welfare Reform Program; Temporary Assistance to Needy Families (TANF) and General Assistance (GA); and

WHEREAS, by way of Resolution No. 420-7-2018, these funds were awarded to various services providers of which Suits for Success, Inc. was one the recipients; and

WHEREAS, by way of a companion Resolution, the New Jersey State Department of Labor and Workforce Development will award additional funds to the County for the Workfirst New Jersey Needs Based Work Support Program in the amount of **ONE HUNDRED TWENTY EIGHT THOUSAND DOLLARS AND 00/100 (\$128,000.00)**; and

WHEREAS, the Director of Family Services wishes to award these funds in the amount of \$128,000.00 to Suits for Success, Inc., 121-125 Newark Avenue, Jersey City, New Jersey 07302 to provide these services; and


NOW, THEREFORE, BE IT RESOLVED, by the Board of Chosen Freeholders of the County of Hudson that:
